Community Resource Drop-In Center:

In 2017, 58% of the 5,400 visitors to the Drop-In Center were homeless - 318 of the total 624 non-duplicated individuals served. Visitors to the Drop-In receive immediate help and assistance to meet their daily needs - emergency food, financial assistance with rent and utilities to keep them from becoming homeless, transportation assistance for doctor and job appointments, clothing, cold weather gear, and shelter items like tents, tarps, and sleeping bags. Drop-In staff and volunteers walk alongside and mentor individuals through housing and job searches, addiction and mental health services, and together discover and work through application processes to additional community resources. Longer term mentoring and professional counseling are provided to help individuals and families improve their life skills, increase their income potential, and strengthen their personal and economic stability.

Kidz Club and Student Leaders:

Held twice weekly, Kidz Club is the only low-cost or free after-school tutoring and mentoring program in Monroe. In 2017, 120 elementary-age students who live in poverty enrolled in Kidz Club. Through Kidz Club, students improve their reading, writing, math, and critical thinking skills; boost their confidence; and increase their chances for a brighter future. Each week students receive life skills training their teachers report help the students become better learners. After graduating Kidz Club, middle and high school Student Leaders come back to serve as volunteers and role models for our younger students. In 2017, 28 Student Leaders volunteered, regularly met together with mentors, learned leadership skills, gave back to their own community, and earned high school credit for their volunteer work.

Weekly Community Meals and Life Skills Classes:

Every Tuesday evening, volunteers from throughout our community: civic groups, churches, businesses, police and fire, and more prepare and serve healthy dinners to our homeless and hungry neighbors. Community volunteers prepare sack lunches for our Drop-In Center visitors, Kidz Club snacks, Growing Together dinners, and more - in all more than 9,000 meals in 2017. Following dinners free child care is available while parents/adults learn to manage stress, finances, parenting skills, and other topics to build stronger families.
