KIDZ CLUB AND STUDENT LEADERS AFTER SCHOOL PROGRAMS: WE FOLLOWED THE MANDATED THE CLOSURE OF SCHOOLS AND SUSPENDED OUR PROGRAMS IN MARCH. OUR STAFF CHECKED IN WITH FAMILIES EVERY WEEK TO MAKE CERTAIN THEY WERE SAFE AND WELL, AND TO HELP WITH REMOTE SCHOOL-RELATED ISSUES LIKE HOW TO SIGN UP FOR DISCOUNTED INTERNET SERVICE AND THEN, HOW TO CONNECT SCHOOL-PROVIDED CHROMEBOOKS TO ZOOM SCHOOL. EVERY MONTH VOLUNTEERS FILLED HUGE "KIDZ PACK" GIFT BAGS WITH SNACKS, FUN ACTIVITIES, GAMES, A BIT OF ACADEMIC WORK, AND THE LIBRARY DONATED OVER 1,000 BOOKS.
